LODGING AND VEHICLE USE FEES January 2019

Lodging and Vehicles Fees are to be mailed to CHHF, PO Box 528, Barnwell SC 29812 at least four weeks before leaving for Honduras. Do not pay fees to Sandy in La Ceiba.

LODGING FEES

\$75 per team member for duration of stay at the Limón clinic. No lodging fee is required for CHHF staff (David Kelly and Mario Miralda), but all other Honduran drivers and interpreters must be included in Team Member Roster and the fee paid.

YELLOW BUS FEE

All teams will be required to pay a \$150 bus fee to cover the week's use of the yellow bus. This is the bus that teams use to travel to outpost clinics and Douglas will use to bring patients to the Limón clinic from distant villages. The yellow bus cannot go beyond Iriona to the east. Gas for the yellow bus is provided by CHHF and is covered by the fee your team pays. Douglas Goff has these funds.

REFUELING OF VEHICLES

The fuel tanks on all CHHF vehicles used must be full when left in La Ceiba. Team leaders should be sure to fill the tank in La Ceiba. The refueling fee for those who travel to Tela or San Pedro Sula has been built into the usage fee.

VEHICLE REGULATIONS

The following criteria will be used to define who is allowed use of vehicles owned by the Carolina Honduras Health Foundation and the rules that must be followed:

- 1. All medical teams scheduled through CHHF may use vehicles.
- 2. For the purpose of CHHF related work, David Kelly and CHHF board members may Use vehicles. At no time may they be used for personal or other project use.
- 3. Vehicles are only to be driven by Honduran drivers approved by David Kelly, CHHF Honduran Director of Operations. CHHF Board members may drive the CHHF vehicles. Team Leaders and other volunteers may <u>not</u> drive the CHHF vehicles.

CONDITIONS OF USE:

- 1. All vehicles (except Yellow Bus) must be returned to La Ceiba within the allotted scheduled time unless prior arrangements have been made through the Team Coordinator and/or David Kelly.
- 2. The Team Leader will be responsible for filling out accident insurance forms for all damage incurred to all CHHF vehicles during their team use, no matter how minor the damage.
- 3. No CHHF van is allowed beyond Limón.
- 4. All travel plans are to be made to ensure arrival before dark. Only in an emergency should CHHF vehicles be on the road after dark.
